Required Minimum Distribution (RMD) Relief Due to CARES Act

The Coronavirus Aid, Relief, and Economic Security (CARES) Act relief bill passed on March 27th. There were several pieces involved in the \$2 trillion aid package, and one specific piece we wanted to share with our clients is the waiver of required minimum distributions (RMDs) for 2020.

If you are required to take an RMD in 2020 and have not yet taken it, you can forgo this year's distribution which provides two benefits to you. First, it will reduce your taxable income for the year; any dollar not distributed from your retirement accounts will translate to paying less in taxes for 2020. Second, by not having to distribute the dollars from your account you can stay invested while the stock market is lower due to recent volatility, which, in turn, will give your investments time to rebound before having to sell them in order to distribute your RMD.

This bill applies to owner accounts and beneficiary accounts (if you have inherited any retirement funds). If you take your RMD as a lump sum each year, we will discuss the pros and cons with you in your next meeting. If you take your RMD distributions on a monthly basis, and you want to take advantage of the relief bill, please give us a call.

Enhanced Client Security for Portal Access

Beginning May 18, Dual Factor Authentication (DFA) will be required to access the GEN Portal. Essentially, DFA is your password plus a code. As of May 18, when you log into the Portal, you will be prompted to register your mobile phone number in order to receive a code via text or email for Portal access. The code will be different each time you log in to the Portal.

Instructions for Dual Factor Authentication:

- 1. Begin from our website: www.genfinancial.com
- 2. Click "Client Log In" on upper right toolbar.
- 3. It will prompt you for 3 security questions.
- 4. Register your cell phone to receive the text codes by entering your cell phone number and click "SAVE" and "REQUEST CODE".
- 5. Be sure to click the box indicating: "I acknowledge that I have read, reviewed, and agree to the Short Code Terms of Service."
- 6. You will receive a code via text message on your cell phone. Enter that code and click "VERIFY".
- 7. You will now have access to the Portal.
